Alan Zawistowski, a veteran and member of the COA Board has provided more information for our local vets in this issue.


"This Veteran's report will cover the different benefits local businesses offer veterans and their families. Veterans can get from a 10% discount at most stores to \$500 off at car dealerships. For example: stores like Carr Hardware, Home Depot, Auto Zone, Advance Auto, Michael's,

Target, and Walmart offer a discount to veterans as do most car dealerships in the Berkshires, New York, and Connecticut.

All the veteran needs to do is show their DD214 or military ID. Therefore, it is so important to register into the VA or your local Pass and ID location like Barns ANG or Westover ARB."

#### **Massachusetts RMV**

(The following information is for anyone who has not already upgraded their MA Driver's License to a REAL ID).

The MA Registry of Motor Vehicles is alerting the public that the U.S. Department of Homeland Security (DHS) has extended the REAL ID full enforcement date from May 3, 2023 to May 7, 2025.

- Beginning May 7 2025, every air traveler 18 years of age and older will need a REAL ID compliant driver's license or identification card, or another TSA-acceptable form of identification, for domestic air travel and to enter certain federal facilities.
- TSA publishes a list of its acceptable identification documents on its website: https://www.tsa.gov/real-id.

RMV Registrar Colleen Ogilvie writes, "The Registry continues to assist any residents seeking a REAL ID credential even though the federal government has extended the full enforcement date until May 7, 2025. While federal REAL ID travel requirements won't take effect for a few years, and customers with a valid U.S. Passport may never need a REAL ID, the RMV and our partners at AAA stand ready to accommodate and provide plenty of time for customers to take advantage of a REAL ID upgrade."
