Beneficiary Protections when Choosing Your Medicare Coverage

The Medicare Advantage Open enrollment season runs from January 1st to March 31st each year. If you are already enrolled in a Medicare Advantage plan anytime between January 1st and March 31st of 2022, you are allowed to make a change to a new Medicare Advantage plan OR to drop your Medicare Advantage plan and switch to a stand-alone Medicare Part D prescription drug plan.

During this period, you may see a number of advertisements and marketing efforts highlighting the benefits that many of these plans offer. In fact, Massachusetts has several new plans being offered to Medicare beneficiaries in 2022. While many of these plans offer good coverage and many new benefits, it's extremely important that Medicare beneficiaries know the right questions to ask before making any changes to their current coverage. Remember:

- You should ask for confirmation that all of your doctors/medical providers accept any plan BEFORE you enroll.
- You should also ask for confirmation that all of your current prescription medications are covered by any plan(s) you are offered BEFORE you enroll.

- You should ask for confirmation that your hospital(s) of choice accept the plan you are considering BEFORE you enroll.
- You have the right to turn down any solicitations for Medicare enrollment information whether in person at your home or over the phone from individuals you do not know.
- You have the right to refuse to give your personal/Medicare information to anyone who asks if you are not sure of your decision to purchase insurance.
- You are not obligated to provide the names of friends or family who may also be seeking Medicare enrollment assistance.
- You have the right to report any misleading marketing practices to the MA Senior Medicare Patrol at 800-893-0890.

Certified SHINE counselors are available, and are able to assist you in making the right Medicare coverage decisions for your personal situation. The service is free and available year-round. They will make sure you are able to compare ALL of the insurance options available to you, not just a select few.

Ageism versus Age Friendly: Two Very Different Ways of Thinking About Age

Over a year ago, at the request of the COA, our Select Board approved Windsor as an "Age Friendly Community" with a goal of adopting livability initiatives including Transportation, Community Health Services, Housing, Communication, and Respect/Social Inclusion.

Ms. Mattina writes, "An individual or a community can think about age from two very different perspectives...One is "ageism" and the other is "age friendly"...Ageism (is) the same... as all other negative '-isms': racism, sexism, classism. (It) is an approach based on pre-determined rather than evidence-based conclusions regarding age: "You shouldn't be doing that at your age" is a good example.

"To help recognize and then banish ageism, the United Nations has declared 2021-2030, The Decade of Healthy Ageing. Activities have been planned around the globe...It will be possible to participate in a wide selection of exciting virtual events and to exchange ideas with people from cultures all over the globe.

"Rather than viewing age from the negative perspective of ageism, the Age Friendly initiative builds on the positive perspective of age, from the youngest to the oldest citizen..."

Windsor is an Age Friendly Massachusetts member along with 82 other towns. Livability initiatives are always a challenge for our rural town—think of transportation, housing, health services, etc. Thus, we must work both within Windsor and out in our greater Berkshire community to help all ages thrive.

Soften ½ cup butter Add ¾ cup sugar, 2 eggs and 6 mashed, ripe bananas. Mix well.
